- ▶ Funding Period: July 1 - August 31, 2024

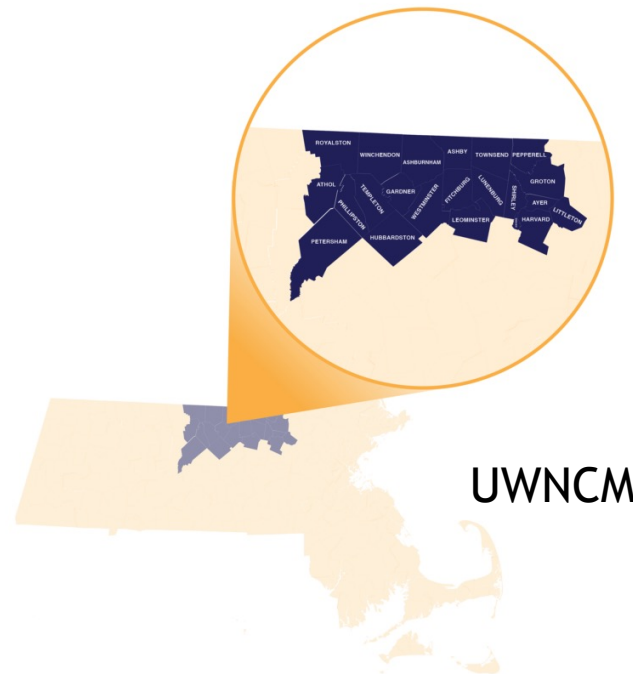
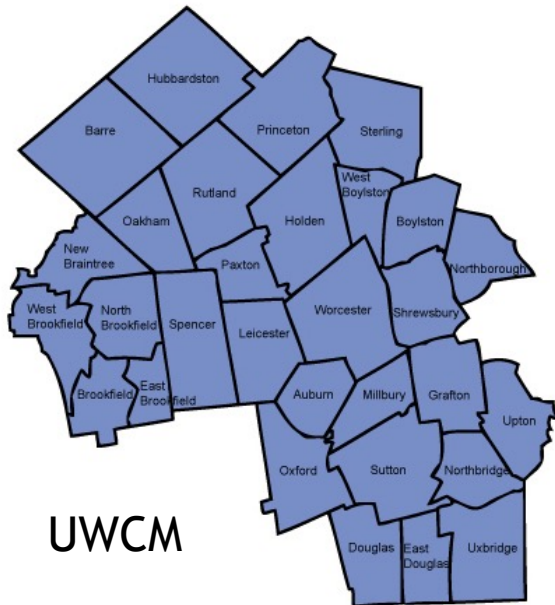
# Funding Source

- ▶ American Rescue Plan— Elementary & Secondary Education Emergency Relief (ARP-ESSER)

- ▶ 501(c)3 or Municipality
- ▶ Central MA United Way Regional Footprint

# Priorities

Funding available to support summer programs that:

- ▶ Provide comprehensive programming for you in pre-k to 6<sup>th</sup> grade
- ▶ Provide opportunities for students in grades 7-12 to gain exposure, skills, or experiences that will enhance post-secondary success

Subgrant awards will range from \$10,000 - \$50,000



# Subgrant Priorities from DESE

- Programs that are operated by non-profit community-based organizations (CBOs) and school districts, including charter schools and collaboratives;
- Programs in communities or schools/districts where at least 25% of students served are considered low-income and/or are in schools in chronically underperforming status;
- Programs that specifically aim to support historically marginalized students, including but not limited to, English learners, students on Individualized Education Programs (IEPs), students who are Black, Indigenous, and People of Color (BIPOC), students experiencing homelessness, in foster care and/or who are migratory;
- Programs that support the Department of Elementary and Secondary Education's (DESE's or Department's) Educational Vision, including supporting the whole student, deeper learning, and culturally and linguistically sustaining practices that contribute to affirming environments where students have a sense of belonging;
- Programs that engage and leverage knowledge and strengths of students, families, staff and community to inform programming design and decisions;
- Programs that offer comprehensive programming at least 3-5 days a week and/or approximately 150 hours per year/summer;
- Programs that are evidence/research-based; and
- Programs that have or want to strengthen partnerships with local schools and/or other community-based organizations.

# Budget/Fund Use from DESE

- ▶ Coordination/Staffing costs (including rates/incentives and costs for recruitment)\*
- ▶ Scholarships for economically disadvantaged students on wait lists or unable to afford programming
- ▶ Transportation
- ▶ Materials/supplies for program activities
- ▶ Food/snacks for participants
- ▶ Mental/behavioral/SEL counselors/supports
- ▶ School/community partner specialist
- ▶ Family engagement liaison
- ▶ Enrichment opportunities (including subcontracting)

*Avoid: Indirect costs, capital improvement costs and/or high supply costs, paying students for participating*
